



JT One for Business Voucher Promotion 2018

Promotion Specific Terms of reference

These Terms of Reference are provided in addition to and must be read in conjunction with the JT One for Business Terms of Reference for JT (Jersey) Limited (“JT”), which are available at www.jtglobal.com/JToneforbusiness. Unless otherwise specified, terms used in these Terms of Reference have the same meaning as defined in the JT One for Business Terms of Reference.

1. This offer is available to new and existing Customers of the £150 per month or £275 per month JT One Plans in Jersey (the “Plans”) who sign or re-sign to one of the Plans for a minimum contract period of 24 months between 3 September 2018 and 31 December 2018 (the “Promotional Period”).
2. A customer signing up to the £150 per month plan in Jersey for a minimum contract period of 24 months during the Promotional Period will receive a voucher of £100 as selected by the Customer from JT’s approved retail partner list (the “Voucher”). A customer signing up to the £275 per month plan in Jersey for a minimum contract period of 24 months during the Promotional Period will receive a voucher of £200 as selected by the Customer from JT’s approved retail partner list (the “Voucher”).

Only one Voucher is available per Customer. A Customer may not purchase more than one of the Plans for the same landline telephone number.

3. A new Customer who, during the Promotional Period signs or re-signs to one of the Plans for a minimum contract period of 24 months will receive a Voucher, according to term (2) above. Only one Voucher is available per new Customer. A new Customer may not purchase more than one of the Plans for the same landline telephone number.
4. This offer is only available to new and existing Customers of JT signing or re-signing to any of the Plans for a minimum contract period of 24 months.
5. The Voucher will be issued at the time the Customer signs or re-signs to any of the Plans for a minimum contract period of 24 months.
6. If the Voucher is not taken by the Customer at the time they sign or re-sign to any of the Plans for a minimum contract period of 24 months, the Voucher may at JT’s discretion be issued to the Customer at a later date provided that the Customer claims the Voucher within a period of 1 month after the Customer has signed or re-signed to one of the Plans for a minimum contract period of 24 months.
7. Use of the Voucher is subject to the relevant retail partner’s terms and conditions, and JT shall not be responsible for any action taken by the relevant retail partner in this respect.
8. The offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the Voucher.

9. This offer may not be taken in conjunction with any other promotion offered by JT during the Promotional Period for the Plans.

Any capitalised term not defined in these terms of reference shall have the meaning given to it in the relevant JT One for Business Terms and Conditions.
11. A cooling off period of 14 days applies to the Plans, and will only be accepted if the Voucher is returned unused. A Customer cancelling any of the Plans during the cooling off period who has redeemed the Voucher will be charged the full face value of the Voucher.
